

# La Clusaz FJT\*\*\* 2019

## Parental discharge Disclaimer

I, the undersigned \_\_\_\_\_ (Name / Surname) as legal representative of the junior competitor \_\_\_\_\_ (Name / Surname) participating in the competition "La Clusaz JFT3 \* 2019" taking place in La Clusaz from 02 to 03 February 2019, waives any claim against the organizer La Clusaz Outdoor SARL, their director(s), their employees and other auxiliaries, Alpine guides, ski instructors, and their representatives for any personal physical or otherwise injury, for any damage to the physical injury, for any pecuniary or non-pecuniary damage and for any prejudice, of which he/she may be a victim by reason of his/her participation in the above-mentioned competition, whatever the causes, for any fault or negligence, except in the case of fraud or serious misconduct.

The undersigned agrees, as a consequence of the foregoing and in accordance with the following arbitration clause, not to bring legal action and undertakes not to bring a civil action in a criminal case against La Clusaz Outdoor SARL, organizer of the event, and its auxiliaries, nor to challenge, to the same extent, its contracting parties. The signatories (competitor and his/her legal representative) are aware that the event to which the competitor has registered is a high-risk competition of which he alone is able to judge his/her ability to face it. Therefore, the competitor (approved by his/her legal representative) declares to be free from any constraint based solely on his/her own assessment of the risks and dangers resulting from his/her participation.

The signatories expressly declare that the decision to participate is consent to the risks inherent to the event, that the competitor has a perfect knowledge of these risks and that he/she is able to appreciate them by his/her quality as a snowboarder / skier very experienced in the practice of mountain out of bound skiing, in particular the signatories declare that his/her participation results from his/her personal appreciation of the snow condition of the run and that if he/she participates, it is because he/she considers them satisfactory.

The signatories expressly declare to be aware that any fall on the part of the competitor is likely to lead to serious injury to his/her physical integrity, or even to death. As a result, the competitor is made aware that he/she may, on the basis of his/her own risk assessment, at any time waive participation in the event, without any prejudice. In such a case, La Clusaz Outdoor SARL undertakes to treat the competitor who quits the competition in the same way as the other participating competitors. The declared signatories must be aware that the risks inherent in such a competition are only partly controllable by the organizer and that in the particular a nil risk can not be taken into consideration, and whatever the

measures taken by the organizer, the latter can not be able to avoid any harmful event. The undersigned is particularly attentive and aware of the following ;

**Avalanches:** They can occur frequently in mountainous areas or on the place of the competition. They are caused by natural phenomena when the slope is particularly steep and the snow layer is thick, they are also caused by changes in weather and the instability of the slopes and the snowpack.

**Snow conditions:** Regardless of the snow conditions on the competition surfaces, many rocks are just below the surface of the snow, which can cause the competitor to fall and / or get hurt following a fall.

**Helicopter Transportation:** The potential for such transportation may be increased in the competition area and in winter weather conditions. **Weather conditions:** They can vary from one extreme to another and are subject to rapid and unpredictable changes. The signatories acknowledge that the competitor is in physical condition to participate in the competition, free from any pre-existing condition that could affect his/her participation. The signatories recognize that the competitor is a specialist in snowboarding / skiing in extreme conditions, that he/she is able to descend slopes whose inclination is greater than 45 degrees that can have fatal consequences in the event of a fall and that he/she is able to appreciate for himself the risks resulting from his/her participation.

**Arbitration clause:** The signatories (competitor and legal representative) undertake to introduce no legal action and to submit to arbitration of the Court of First Instance for any dispute arising from the application of this disclaimer and for any damage resulting from fraud or serious misconduct and therefore asks its agents, representatives and heirs to submit to arbitration as aforesaid. The seat of this Tribunal is in Annecy. Only French law is applicable. The legal representative of the competitor finally declares to be at least 18 years old, to have read and understood the terms of this release before signing it and accepts that it applies by right to his/her heirs, his/her family, his/her executors and administrators and their successors.
